REQUEST TO INVESTIGATE THE CIRCUMSTANCES LEADING TO THE ISSUANCE OF PRIMARY SCHOOL LEAVING CERTIFICATE TO AMINU A. BANDE BUT PRESENTED TO INEC BY MAJOR GENERAL AMINU BANDE RTD., ON 15 JULY 2022

We are Solicitors to the All Progressives Congress (APC) on whose instruction we write this petition and request your office to investigate the circumstances leading to the issuance of an alleged primary school leaving certificate to one, Aminu A. Bande. A copy of the certificate is attached as *Annexure A*.

On the 15 July 2022, the above-mentioned Primary School Leaving Certificate was presented by Major General Aminu Bande (Rtd) to INEC in an attempt to fulfil the requirements for eligibility to contest for the office of Governor of Kebbi State, under the platform of the People's Democratic Party (PDP). A copy of the Form EC 9 completed and submitted to INEC by Major General Aminu Bande (Rtd) and the PDP is attached as *Annexure B*.

We observed that the purported primary school leaving certificate bears two dates at the foot thereof; one purporting to be the date the pupil signed the certificate, which was apparently altered from "JAN 1976" to "DEC 1976", while the second was the date on which the issuing authority, (Headmaster) signed the certificate, that is, 10 December 1987. Curiously, however, even though the North-Western State of Nigeria ceased to exist since February 1976 upon the creation of Sokoto State, the said Primary School Leaving Certificate was allegedly issued by the government of North-Western State of Nigeria. Also, the pupil named in the certificate was alleged to have spent only six years, as opposed to the 7 years prescribed period at the time.

Furthermore, as part of the documents submitted to INEC for the nomination of Major General Aminu Bande (Rtd.) as Kebbi State Governorship Candidate for the PDP, were documents of the Deputy Governorship candidate, one Samaila Salihu Bui. The Form EC9 is attached as *Annexure C*. We observed that the said Samaila Bui was alleged to have attended Bui Primary school from 1967 to 1973, whereupon he was issued with a certificate by the North-Western State of Nigeria in 1973. This seemed to be proper, knowing that as of 1973, the North-Western State was still in existence and pupils spent 7 years in primary school as indicated above. Save, however, that while the certificate indicated it was revised in 1974, it was said to have been issued earlier – 1973. The primary school certificate for Samaila Salihu Biu is separately attached as *Annexure D*.

Also, a careful comparison of the certificates purportedly issued to Aminu A. Bande and Samaila Salihu Bui will show that, whereas the certificate issued to Samaila was earlier in time with serial number **NWS 064792**, the certificate purportedly issued later in time to Aminu A. Bande, as appropriated by Major General Aminu Bande (Rtd), has serial number **NWS 028021**. For avoidance of doubt, the serial number of the later certificate was earlier than that of the certificate issued in **1976** or **1987** - 3 or 14 years later, as the case may be.

Another curious feature of the Certificate issued to Aminu A. Bande, is the signature of the pupil in 1976, when compared with the signature on the oath of office by 2LT Aminu Bande, when he was commissioned in 1986. A copy is attached as *Annexure E*. It is obvious that the contraption as signature of the pupil on the primary school certificate in 1976, is the same as the signature on the oath of office sworn by Aminu Bande as commissioned officer of the Nigerian Army in 1986, 10 years after the signature on the primary school leaving certificate was allegedly appended by the same pupil. It is left to be fathomed how the pupil maintained the flow of his signature since 1976. Or could it be that the primary school certificate was procured at a time when the contraption as his signature had already matured as shown on the document dated 20 December 1986 (hereto attached as Annexure E)? All these, we expect, would be unravelled by this investigation.

Premised on the forgoing, we strongly suspect that the certificate was improperly obtained; it was fraudulently procured or forged, as it was impossible, amongst other things, for a non-existent entity to issue the said certificate. At the risk of repetition, as of **December 1976** or **December 1987** (the two dates on the certificate), there was no North-Western State that could have issued the said primary school certificate to Aminu A. Bande.

We therefore most respectfully call on you to direct a full-scale investigation into the circumstances leading to the issuance of the certificate and prosecute anyone found complicit in the issuance thereof.

We note that this document may have formed part of the documents presented by Major General Aminu Bande (Rtd) to join the Nigerian Army and that leaves much to be desired.

Thank you for your anticipated expedited action.
