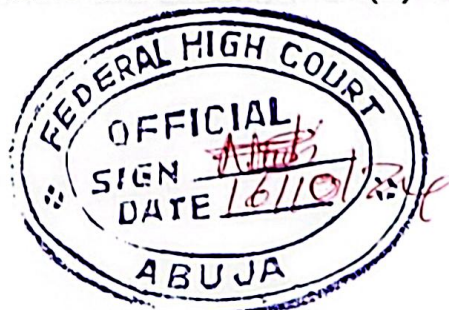
CHARGE

At the Session Holden at Abuja on the.....day of.....2024,
the Federal High of Nigeria Abuja Division is informed by the Commissioner
of Police FCT Police Command, Abuja that you FELIX CHUKWUMA
ASHIMOLE is charged with the following offences:

COUNT 1

That you FELIX CHUKWUMA ASHIMOLE, male, of Che Oyinatumba Associates suite 22 Ejimiz Plaza, Kubwa, FCT Abuja, on 21/08/2024 within the jurisdiction of this Honourable Court, did intentionally publish online on a WhatsApp group platform known as "Law Center" which has about 540 lawyers as members about one Jude Ezeobi, male, of Zone 4, Wuse, Abuja that *"The family is shocked and scandalized that Mr Ezeobi and his committee of friends has formed a condolence WhatsApp group aimed at soliciting support from unsuspecting sympathizers towards Ulonna's burial"* a publication which you know, to be false for the purpose of causing Jude Ezeobi and the members of his family injury, annoyance, ill-will and insult. You thereby committed an offence punishable under Section 24(1) b of the

CYBERCRIMES (PROTECTION, PREVENTION ETC) ACT, 2015, (AS AMENDED) 2024.

COUNT 2

That you FELIX CHUKWUMA ASHIMOLE, male of Che Oyinatumba Associates, suite 22 Ejimiz Plaza Kubwa, FCT Abuja, on 21/08/2024 within the jurisdiction of this Honourable Court, did intentionally publish online on your online news platform known as "Kubwa Express" which is widely circulated globally that one Jude Ezeobi, male, of Zone 4 Wuse Abuja had hoodwinked grieving friends and associates by calling for contributions through a fraudulently concocted committee of friends on whatsapp group to help him plan the burial of Ulonna Inyama, his ex wife, information you know or reasonably ought to know to be false, for the purpose of causing Jude Ezeobi and the members of his family insult, injury, annoyance, ill will and insult. You thereby committed an offence punishable under Section 24(1) b of the CYBERCRIMES (PROTECTION, PREVENTION ETC) ACT, 2015, (AS AMENDED) 2024.

COUNT 3

That you FELIX CHUKWUMA ASHIMOLE, male, of Che Oyinatumba Associates, suite 22 Ejimiz Plaza, Kubwa, FCT Abuja, on or about September 2024, within the jurisdiction of this Honourable Court, after previously deleting false publication you made against Jude Ezeobi and publishing an unreserved apology to Jude Ezeobi, did intentionally, re-published online on your online news platform known as "Kubwa Express" which is widely circulated globally that one Jude Ezeobi, male, of Zone 4

Wuse Abuja had hoodwinked grieving friends and associates by calling for contributions through a fraudulently concocted committee of friends to help him plan the burial of Ulonna Inyama, his ex wife, which said information you know or reasonably ought to know to be false, for the purpose of causing said Jude Ezeobi and the members of his family injury, annoyance, ill will and insult. You thereby committed an offence punishable under Section 24(1) b of the CYBERCRIMES (PROTECTION, PREVENTION ETC) ACT, 2015, (AS AMENDED) 2024

COUNT 4

That you FELIX CHUKWUMA ASHIMOLE, male, of Che Oyinatumba Associates, suite 22 Ejimiz Plaza, Kubwa, FCT Abuja, on 21/08/2024 within the jurisdiction of this Honourable Court, did intentionally publish online, on a WhatsApp group platform known as "Law School Class of 2003" which has about 743 lawyers as members about one Jude Ezeobi, male, of Zone 4, Wuse, Abuja that *"you cannot defame a man who has no character. He committed bigamy, withheld his earlier subsisting marriage and contracted a fresh one. The woman discovered and sued for nullification of the marriage. Since then, Jude's ego is bruised and he has been running from pillar to post"* information you know, or ought reasonably to know to be false, as the said Jude Ezeobi has never been convicted of bigamy or any offence whatsoever, but you nevertheless published same with the intention of causing bullying, harassing and causing Jude Ezeobi injury, annoyance, ill-will and insult. You thereby committed an offence punishable under Section 24(1) b of the CYBERCRIMES (PROTECTION, PREVENTION ETC) ACT, 2015, (AS AMENDED) 2024.

COUNT 5

That you FELIX CHUKWUMA ASHIMOLE, male, of Che Oyinatumba Associates, suite 22 Ejimiz Plaza, Kubwa, FCT Abuja, on 21/08/2024 within the jurisdiction of this Honourable Court, did intentionally sent a message to Jude Ezeobi,, male, of Zone 4, Wuse, Abuja using your mobile telephone number +2348033916133 that "*I have this and many more documents including the records of proceedings that will bury you if you want to go on this route*" which said statement/information you know, or ought reasonably to know to be menacing as well as threatening of the reputation of the said Jude Ezeobi. You thereby committed an offence punishable under Section 24(1) a & b and 24 (2) a & c of the CYBERCRIMES (PROTECTION, PREVENTION ETC) ACT, 2015 (AS AMENDED) 2024
